#### **Position Summary:**

The Department of Counselor Education and Rehabilitation in the Kremen School of Education and Human Development at California State University, Fresno seeks applicants for a tenure-track, academic year position as an Assistant Professor in Counselor Education with a focus on preparing graduate students for a Master of Science degree in Counseling with an emphasis on Student Affairs and College Counseling. The successful candidate will teach graduate students at the master's degree level; supervise practicum and fieldwork experiences; advise students in master's project, thesis work, or comprehensive examination as a culminating experience; conduct research; and engage in University and community service.

#### Overview:

Fresno State has a strong history of service and preparation of education and counseling professionals, celebrating 100 years in 2011. The Kremen School of Education and Human Development has been nationally accredited (NCATE) since 1954 offering 34 distinct credentials, many Masters' degree programs, and a Doctorate in Educational Leadership. The Counselor Education Program at Fresno State includes a masters of science degree in counseling with three options in 1) Student Affairs and College Counseling, 2) School Counseling, 3) Marriage, Family and Child Counseling (CACREP accredited) or 4) Clinical Rehabilitation and Mental Health Counseling. The program also includes the Pupil Personnel Services credential (School Counselors). The successful candidate will teach courses in the Student Affairs and College Counseling track as well as core courses in counseling.

### **Required Education:**

An earned doctorate (Ph.D. or Ed.D.) in Counselor Education from a CACREP accredited institution (or equivalent) with an emphasis in Student Affairs and College Counseling or other closely-related discipline is required. Applicants nearing completion of the doctorate (ABD) will be considered. For continued employment in the tenure track position, the doctorate must be completed by January 1, 2019.

#### Required Experience:

1) Teaching and/or Counseling experience in Student Affairs at the college or university level; 2) Ability to demonstrate a commitment to working effectively with faculty, staff, and students from diverse ethnic, cultural, and socioeconomic backgrounds.

#### **Preferred Qualifications:**

Preference will be given to the candidates who demonstrate the following qualities: 1) Eligibility for licensure as a professional counselor or related license in the State of California; 2) Teaching experience at the undergraduate or graduate level; 3) Experience

working in a culturally diverse college and/or university; 4) Research, practice or related interest in Student Affairs and College Counseling; 5) Specific interest in teaching College Student Development Theories and College Counseling; 5) Demonstrated record of excellence in research, teaching, and scholarly activities; and 6) Experience participating in or assuming leadership roles in the profession of Student Affairs and College Counseling, Counseling, Counselor Education, (e.g., ACA, ACES, ACPA, NASPA) or relevant professional organizations.

#### **Application Procedures:**

Review of applications will begin November 6, 2017, and will continue until the position is filled. To apply, applicants must complete an on-line application at jobs.csufresno.edu and attach the following: 1) a cover letter specifically addressing required education, experience, and preferred qualifications; 2) a curriculum vitae; and 3) a list of three professional references. Finalists will be required to submit three current letters of recommendation and official transcripts.
